5.1. 6:00 PM Stephanie Button-Historic Downtown Kennewick Partnership/SOCO

Stephanie Button gave a brief overview of the South Columbia Creative Arts District and public art in downtown Kennewick. Ms. Button introduced local sculptor, Tom McClelland and presented his idea

for a bronze and stainless steel piece titled "Still Dancing". The preferred location for the sculpture would be on the corner bump out located at S. Washington St. and W. Kennewick. Ave.
