Thursday, October 20, 2016

A-Shift

Trespass/2600 blk W Bruneau- Male was at the location making threats to patrons. Nobody wanted to pursue charges rather simply trespass him from the location. He was trespassed and went on his way.

Malicious Mischief/500 blk S Buchanan St- Reporting party found one of her tires slashed this morning. She was able to swap it with the spare. She suspects a former boyfriend but cannot put him at the scene.

Burglary/2500 blk W Falls Ave- Complainant's organization recently purchased this building and is in the process of remodeling it. **Someone left the door unlocked** and they found a syringe, a foul bodily odor and tools missing. They have seen transients in the area of the building lately. Requests extra patrol.

Trespass/7400 blk W Canal Dr- Transient walked into the store and was acting strangely and began spraying a substance in the air claiming it was ecstasy. The assistant manager of the store got scared and locked herself in the back room but left her employees and customers in the store while she called police. Upon arrival officers found the male standing outside in his urine stained sweat pants and jacket. The assistant manager was retrieved from the back room. She requested that he be trespassed from the store after hearing that he was spraying a bottle of cheap perfume he got from another store.

Warrant Arrest/3800 blk Plaza Way- 28 year old female was reported to be at and that she had several felony warrants from Oregon. A records check showed she had two extraditable felony narcotic warrants out of Umatilla County. She was located, medically cleared and transported to Benton County jail and booked on a fugitive from justice charge.

C-Shift

Warrant Arrest/3300 blk W 19th Ave- Juvenile female was located at the location after an anonymous report that she was there. She is a runaway and had a warrant for her arrest. She was booked into Juvenile Detention.

Warrant Arrest/2600 blk W Bruneau Pl- Officers responded to a male at the location working on his car. The Officers contacted the male who provided a false name. Another resident provided his actual name after he assured Officers that he had given his real name, and just did not have ID because he lost it. He was arrested and booked on his felony warrant with false reporting charge added.

CAT

Warrant Arrest/Grand Ronde & Ione St- Detectives Schwartz and Dorame recognized a male and were aware he was wanted. He was arrested on outstanding DOC and Franklin County warrants.

Friday, October 21, 2016

B-Shift

Vehicle Prowl/2400 blk S Edison St- Officer Meiners responded and contacted the complainant who reported that his 2005 Ford F150 PU was entered by an unknown

suspect. His wallet with ID, credit/debit cards, and CPL were taken along with a blue tooth earpiece and sunglasses. He believes his Social Security card was in his wallet as well. He believes his car was locked, **but there was no damage.**

Vehicle Prowl/2400 blk S Arthur Ct- Officer Meiners responded and contacted complainant who reported his work vehicle, a 2014 Toyota Prius, was entered by an unknown suspect. His work laptop and tool bag were taken from inside the vehicle. He believes that he locked the vehicle last night, **but there was no damage to the vehicle.**

Vehicle Prowl/2200 blk S Edison St- Officer Jones responded and contacted the complainant advised that his vehicle was broken into overnight and sunglasses and \$30.00 cash taken from the center console. He believes his vehicle was locked, but **there was no damage to the vehicle.**

Vehicle Prowl/2200 blk S Arthur Lp - Officer Meiners responded and contacted the complainant who advised she had planned on going hunting today, so she loaded her vehicle with supplies. Sometime overnight, an unknown suspect took a Ryobi tool set containing a chainsaw, drill, and air compressor from the truck. She also advised that several hunting knives, flashlights, and an RV battery were also missing. **The truck was left unlocked.**

Assault DV/1200 blk S Olympia Pl- Officers Johnson and Jones responded to a disturbance in progress. Female called to report she had been assaulted by her boyfriend. He fled prior to police arrival, but was contacted a few blocks away. He denied assaulting her and a No-Contact Order was issued at her request.

Order Violation/6400 blk W 38th Ave- Officer Jones responded to an order violation report at the station. Complainant came to report that a male has been violating the active order against their son in common. She advised that she was told that he has been coming to their son's school, which is one of the prohibited places, and giving him snacks. She advised that she would contact the school on Monday to obtain further information. Investigation ongoing.

Robbery/Kennewick Area- Officers responded to a robbery that just occurred near the area of W Clearwater Ave and N Union St. The complainant called 20 minutes after two unknown suspects entered the residence, which the victim refused to provide, and hit him over the head with a handgun. He had his wallet with \$400.00 cash, ID, credit cards, and Qwest card taken. He also advised that his 30mg Oxycodone with about 114 pills and his 15 100microgram fentanyl patches were also taken. Referred to detectives.

D-Shift

Verbal Domestic/2200 blk W 13th Ave- Complainant reported a male neighbor yelled that he had been stabbed and went back into the above location. The male was

contacted along with his girlfriend. Both were intoxicated and had been arguing because she hid his wallet and cell phone when he was in the shower. The stabbing was unfounded and he left.

Mental/1500 blk N Montana Ct- Complainant reported that 19 year old male sent her a text stating he wanted kill himself. He was contacted and said he no longer wanted to hurt himself and he sometimes walks into things to hurt himself, but never thought about killing himself. Crisis Response was contacted and said they would talk to him later and no further police assistance was needed.

Assault/1100 blk W 10th Ave- 49 year old female has downs syndrome and pushed and tried to hit her caregiver. The company the caregiver works for wants her arrested. There have been three similar incidents this year. This report was sent for review.

CAT

Warrant Arrest/1300 blk W 13th Ave- Detectives located and arrested Diane female in front of her apartment on outstanding warrants.

Narcotics, Driving while License Suspended & Warrant Arrest/ Zillah St & 4th Ave- Detectives contacted male and female in a vehicle after finding out they had outstanding warrants for their arrest. He was driving with a suspended license. A meth pipe was observed in the driver side door panel during the arrest. A search warrant will be executed on the vehicle.

Saturday, October 22, 2016

B- Shift

Hit and Run/900 blk E Columbia Dr- Officer Jones contacted employees in reference to a vehicle which had struck their fence. During the night the suspect vehicle hit the fence and was left at the scene. The owner was contacted with assistance from Pasco PD. The owner reported he had assisted a friend purchase the vehicle. Phone contact was attempted with the "friend" but the number was not in service.

Order Violation/400 blk E 8th Ave- Officers were dispatched to this residence for an order violation in progress. The complainant stated that a male was at the location in violation of a No Contact Order with the complainant's daughter. He left in a vehicle prior to police arrival but was located a few minutes later at 10th and Washington and fled on foot as he was contacted. Officers chased the male on foot for approximately 30 minutes through yards, fields and neighborhoods. Officers eventually arrested him for

violation of the No Contact Order, resisting arrest; criminal trespass and Driving while License Suspended 2nd. He also had an outstanding warrant.

Auto Theft/1100 blk W 10th Ave- Complainant reported that his 2000 Ford Explorer was stolen from the parking lot. A co-worker was borrowing the vehicle and **he appeared to leave the key in the vehicle ignition**. Entered as stolen.

Vehicle Collision/1st Ave & Fruitland St- A Ford Explorer, driven by male was traveling west when it drifted to the right and struck four parked vehicles. Driver was cited for improper lane travel.

Vehicle Prowl/2400 blk S Arthur Ct- Complainant reported that an unknown suspect stole tools and a toolbox out of the bed of his truck. The **tools were not secured** at the time of the theft. Appears related to the prowls handled on Friday morning.

D- Shift

Theft/100 blk S Washington- A female came into the location and made up a story about a pizza that she bought the day before. There was no record of her purchase and she was trying to get a free pizza. The female convinced another customer to buy her a pizza. The female attempted to conceal the tip jar that was on the counter under her shirt, but dropped it. The suspect fled prior to officers arriving.

Disturbance/200 blk S Benton- Officer Canada responded to a disturbance. When officers arrived a male exited, saw the officers and went back inside and turned off the lights. Containment was set and a few minutes later a female exited and said everything was OK. The male was eventually contacted and after a short name game was identified. He was arrested for and outstanding warrant out of Pasco and charged with Obstructing. He was booked at the Benton County jail.

Theft/100 blk S Washington St- A male stole a case of beer and cigarettes and left in a vehicle. The clerk got the plate of the vehicle and it was located in the 700 blk S Fir. The suspect was identified by the victim and was booked for the Theft and three felony warrants

CAT

Warrant Arrest/600 blk N Tweedt St- Detectives contacted a female and arrested her for a felony Franklin County Warrant. She was booked into Franklin County Jail.

Sunday, October 24, 2016

B-Shift

Trespass/500 blk S Auburn St- Officer Engel contacted male who was sleeping inside the post office. He had previously been trespassed from the location and was arrested and booked.

Shoplift/1100 blk N Columbia Center Blvd- Loss prevention reported that a female filled up a grocery cart with food items and exited the store without paying. She was detained and returned to the security office. When she learned that PD had been called she fled out of the office of foot.

Fraud/Kennewick Area- Sgt Walters contacted complainant in reference to a wire transfer fraud. They had a business contract with a company in China to produce countertops. During the negotiation process via email, their email was hacked and a suspect sent him a fraudulent sales contract. The money was then wired to the suspect's bank in Hong Kong. The business owner is currently in China attempting to deal with the bank. Report forwarded to CID.

Theft & Fraud/100 blk N Ely St- Complainant reported that he had been working. When he returned to this locker he found the lock missing along with his wallet. He returned home and cancelled the credit cards in the wallet. Key Bank advised that the suspect had already attempted two fraudulent charges. Officer Johnson contacted the first business and spoke with the clerk. The clerk denied the transaction and had video of the suspect. Still photographs were obtained and Officer Johnson went back to the gym where employee immediately recognized the male who had just signed up for a 7 day pass. Contact was attempted at his last known address but he was not there. His girlfriend stated he is living in Prosser. The Prosecutor was contacted and approved fraud charges. Follow up continuing.

D-Shift

Attempted Burglary/2900 blk S Everett Pl- The resident heard footsteps in their gravel driveway. They turned on their porch light a male ran from their driveway. There was a fresh hand print on the garage door. The suspect was wearing gloves; there was no definition on the print. An area check did not produce the suspect.

Order Violation/1100 blk W 10th Ave- Officer Canada responded to an order violation. Male attempted to contact his mother in violation of a court order. He fled the scene prior to the officers arriving. He was located about an hour later in the area of Kennewick Avenue and Alder where he was arrested.

Threats/5000 blk W Clearwater- First female threatened to assault second female in a text exchange. A criminal Citation was prepared for mailing.

Vehicle Prowl/2500 blk W Deschutes- Complainant reported that an unknown suspect entered her locked vehicle and took her laptop computer.

Mental/3600 blk W Kennewick Ave- Female told her boyfriend that she wanted to end it all and have all the pain go away. She was contacted and said she did think about killing herself but was not going to. Crisis Response talked to her on the phone and told officers that she was not a threat to herself.

Vehicle Prowl/400 blk N Volland St- Complainant reported her husband saw a male in her vehicle. The male was asked what he was doing and the male said, "Nothing". The male then fled on foot. A Bluetooth device was missing from the vehicle.

Trespass/700 blk N Center Parkway- Officers responded for report of several people making noise on the property. Officers contacted a female who was attempting to hide. She said she was there to use the Wi-Fi. Officers located the rest of the group, four adults and a juvenile male in a vehicle after a citizen saw them leave the school property. The officers checked the buildings for damage, none was located but what appeared to fresh human feces was located by one of the buildings. Four subjects were arrested for Criminal Trespass Second Degree. One male had marijuana on his person and was also charged with Minor in Possession of Marijuana. The other male was also arrested for a warrant for failing to register as a sex offender.

Mental/600 blk W 10th Ave- 12 year old male was standing on a bed staring at the wall and said different voices were telling him to kill people. He also said the voices were telling him to kill the officers. He was transported to Kadlec for Crisis Response until they could get him to a facility.
