## Monday, December 5, 2016

### A Shift

**Graffiti/400 blk E 4th Ave-** Unknown suspect spray painted on the property's fence line. The owner of the property advised he would take care of cleanup.

**Graffiti/100 blk S Washington-** Unknown suspect spray painted on the exterior door and electrical box. GAP was notified.

**Graffiti/400 blk E 6th Ave-** Unknown suspect spray painted on the building. Owner is cleaning up the damage.

**Graffiti/00 blk E 3rd Ave-** Unknown suspect spray painted on the building. GAP was notified.

**Graffiti/700 blk E 5th Ave-** Unknown suspect spray painted on the fencing that belonged to four other addresses including 700 blk E 5th, 600 blk and 700 blk E 6th Ave. GAP was notified.

**Graffiti/800 blk S Ivy St-** Unknown suspect spray painted on the fence and nearby light pole and utility box. GAP notified.

**Burglary/6900 blk W Clearwater Ave-** Unknown suspect cut a 4 foot hole into the chain link fence on the side of their storage lot. Reporting party doesn't think anything was stolen at this time.

**Mental/500 blk S Dayton St-** 16 year old female called 911 to report she wanted to kill herself. Officers contacted her at the school and eventually after talking to Crisis took her for a medical release then assistance.

## **C Shift**

**Auto Theft/800 blk W John Day-** Complainant **left his pick up running as he went back inside to grab his jacket.** When he came back out he saw his truck driving away. He called in to report the theft. A short time later the residence in the 400 blk N Hartford reported a running truck parked in their driveway unoccupied. The truck was confirmed to be the stolen vehicle and returned. There was nothing taken and no witnesses or evidence to identify a suspect.

**Warrant Arrest/3900 blk W Hood Ave-** Officers responded to a possible burglary which was not what actually occurred. Male had been invited over by one of the residents and was not known to the others. He had a warrant and was booked after medical clearance for intoxication.

**Warrant Arrest/10<sup>th</sup> & Steptoe-** Officer Harrington contacted a male who was arrested on a warrant for assault DV.

**Burglary/1200 blk W 10<sup>th</sup> Ave-** Complainant reported that his apartment had been burglarized with 8 expensive guitars and several speakers and amps being stolen. He also reported that his guitar pic collection worth \$10,000 was missing. He advised he left his apartment at 22:00 and returned at 23:50 and he made it clear he had receipts to account for his whereabouts. He also made it clear that he had photos of his stolen property to show what each item was. He has \$100,000 coverage in insurance. His apartment was ransacked. His story did not add up, nor did what appeared to be staged evidence. The onsite security guard was also present for a large portion of the time the burglary would have occurred and did not see anything. When Officers asked to check his garage he became defensive. This ended with him telling Officers to get a search warrant and he knew his rights. No suspects.

**Tuesday, December 6, 2016**

**A Shift**

**Theft from Vehicle/2000 blk W 28th Pl-** Reporting party **found his unlocked car** entered last night and two .40 cal loaded Glock magazines missing. No suspects.

**Auto Theft/1000 blk W 40th Ave-** Complainant reported her yellow 2002 Volkswagen Beetle was stolen from their driveway sometime between 2030 hours last night and 0630 hours this morning.

**Auto Theft/2000 blk W 9th Ave -** Complainant found his 1995 Green Honda Accord, missing from the residence. No suspects.

**Auto Theft/200 blk N Morain St-** Complainant advised his white 2002 International Harvester box was stolen. The truck box has the company name of SPEEDY DELIVERY on the sides.

**Auto Theft/2000 blk W 19th Ave-** A blue 2008 Nissan Quest van was stolen.

**Graffiti Arrest/E 1st Ave & Washington St-** Officer Hamel arrested a 19 year old male for spray painting graffiti on the building. He was booked into jail for destruction of property.

**C Shift**

**Threats/5500 blk W Hildebrand Blvd-**Officers responded to a disturbance where a male was armed with a gun. Female reported that her roommate had moved out earlier and that they got into a physical argument. She reported that he had displayed a firearm. Officers located the male who was not cooperative with a statement. He did advise that he had a firearm as it was an item he took with him while moving out. He denied displaying it and said that the female is suicidal so he did not want to leave a firearm. Another involved witness was interviewed providing a statement that nothing had happened at all. Statements taken and case sent for charging review. No one involved provided consistent accounts of what actually took place.

**Warrant Arrest/3100 blk W Kennewick Ave-** Officer S. Peterson a 33 year old male behind the business. The male was arrested on a felony DOC warrant. He was booked after medical clearance.

**Graffiti/100 blk E Columbia Drive-** Complainant reported new graffiti to the building. They had checked the building at midnight and again at 03:15, so the graffiti is

known to have been done between those times. There were several other area buildings also found with graffiti. GAP notified for cleanup.

## **CAT**

**Warrant Arrest & Narcotics /27<sup>th</sup> & Vancouver St-** CAT detectives received information a 29 year old male was a passenger in a vehicle. Detectives stopped the suspect vehicle and arrested the male for a DOC warrant. Detectives recovered a small amount of illegal narcotics. The narcotics were sent to WSP lab for analysis. Follow-up to continue.

## **Wednesday, December 7, 2016**

### **B Shift**

**Vehicle Prowl/3300 blk S Quincy Pl-** Complainant reported that an unknown suspect **entered his unlocked vehicle** during the night. The suspect stole his wallet which contained a Banner Bank credit card.

**Warrant Service/200 blk S Dawes St-** Officers responded to a report of a female sleeping in a vehicle in the parking lot. Contact was made with the female who had an outstanding warrant. She was arrested and booked.

**Auto Theft Attempt/5100 blk W Clearwater Ave-** Complainant reported that an unknown suspect entered her vehicle and attempted to steal it. Damage was found to the steering column area.

**Vehicle Prowl/2100 blk S Zinser St-** Complainant reported that an unknown suspect entered his vehicle and stole his Snoop Dog tickets. Entry was made through a previously broken window.

### **D Shift**

**Narcotics/Entiat & Mayfield-** Officer Kiel responded to a disturbance and it was determined to be non-physical. The female had a warrant for her arrest and had a glass smoking device on her person that contained Meth residue. She was booked on the warrant and the pipe was sent to the lab.

**Assist/2000 blk W 52nd Ave-** Sergeant Jackson and Officer Kuhn responded because a male had bought an artillery shell at an auction and became concerned that it might be live. The Yakima EOD Team was contacted and sent pictures of the shell. They were concerned about the shell and responded to assist KPD. The shell was transported to the range where the EOD team detonated it.

***Theft/2800 blk W Kennewick Ave-*** Officer Kuhn responded. A black male entered the store and took a bottle of Vodka without paying for it.

## **Thursday, December 8, 2016**

### **B Shift**

***Graffiti/2000 blk W 7th Ave-*** An unknown suspect tagged the outside of the restrooms with graffiti. Parks Dept was notified to handle clean up.

***Theft/800 blk W 23rd Pl-*** Complainant reported that she was contacted by GESA in reference to four of her checks being found on a person in a rehab center in Spokane. The checks in question were mailed by her on 11/28/16 from her unsecured mailbox. She was advised that Spokane PD is also investigating the incident.

***Theft/8500 blk W Gage Blvd-*** Loss prevention observed a male conceal items on his person and then exit the business without paying. He was detained in the parking lot by loss prevention and was booked on theft and an outstanding warrant.

***Identity Theft/800 blk N Columbia Center Blvd-*** Officer Meiners contacted complainant reference to an identity theft. She reported that a male opened up a cell phone account in the name of her business. The suspect ran up a bill of \$1100. Officer Meiners is contacting the Sprint fraud department to follow up.

### **D Shift**

***Order Violation/900 blk S Auburn St-*** Complainant was at the location having just given birth. She reported that her ex-boyfriend has been texting her because he might be the father of the child and she has an order that names him as the respondent. He was contacted by telephone and told to stop contacting Mikayla. Forwarded for review.

***Theft/1300 blk N Columbia Center Blvd-*** A 17 year old female and two 16 year old females were caught shoplifting. The employees only wanted them trespassed and they were. The 17 year old had a warrant and was booked at juvenile for that.

***Domestic/7700 blk W 4th Ave -*** Officer Canada responded for two separate verbal disturbances between husband and her intoxicated husband. At the end of the second call she and her three children were provided a room at Motel via the Community care Fund.

***Burglary/7800 blk W Deschutes-*** An unknown suspect forced the back door open. Jewelry and an X-Box are missing. No latent fingerprints were located and an area canvas did not produce any leads.

***Mental/300 blk N Fillmore*** – Male left Crisis response saying he was going to jump off a bridge or hang himself. He was contacted at his residence and agreed to go back to Crisis.

***Aggravated Assault/900 blk W 23<sup>rd</sup>***- Male placed a pillow over his wife's face and was going to kill her. She is scared of him and he fled prior to the police arriving. An ATL was broadcast.

## **CAT**

***Stolen Auto Arrest/100 blk N Ely St***- Early Friday morning CAT detectives were on extra patrol in the 100 block of N Ely St. The detectives observed an unoccupied stolen vehicle in the parking lot. The vehicle had been reported stolen to Pasco PD in November. Detectives conducted surveillance on the vehicle and eventually two males were seen entering the vehicle. Detectives and KPD patrol officers arrested a 27 year old male for Possession of a Stolen Vehicle. The male passenger was arrested for an outstanding arrest warrant, possession methamphetamine and possession of a dangerous weapon. Both were booked into Benton County Jail.

***Warrant Arrest/600 blk N Columbia Center Blvd***- CAT Detectives received information that a female was in a motel room. Detectives contacted her and arrested her for two warrants. She was booked into Benton County Jail.
