

# Gift Card Giveaway

## City of Kennewick Electronic Billing Statement Promotion and Gift Card Giveaway

Official Rules:

- 1. NO PURCHASE NECESSARY TO ENTER OR WIN.** The City of Kennewick Finance Department, electronic billing statement promotion and Gift Card Giveaway ("Giveaway"), begins at 8:00 AM on Monday, October 24th, 2016 and ends at 11:59 PM (PST) on Tuesday, December 20th, 2016 (the "Promotion Period").
- 2. SPONSOR.** The City of Kennewick Finance Department ("Sponsor"), 210 W. 6<sup>th</sup> Ave, Kennewick, WA., 99336. The Giveaway is in no way sponsored, endorsed, administered by, or associated with Kennewick Waste Management. By entering, you understand that you are providing your information to the Sponsor and not Kennewick Waste Management. The Sponsor will not sell or use the information provided for any purpose not associated with the City of Kennewick Finance Department. The prize was donated to the Sponsor by Kennewick Waste Management and does not constitute public funds. Questions, comments or complaints regarding the Giveaway must be directed to the Sponsor.
- 3. ELIGIBILITY.** The Giveaway is open to all individuals 18 years of age or older who are enrolled to receive utility billing statements electronically from the City of Kennewick by the end of the Promotion Period. Employees, officers and directors of the Sponsor, its affiliates, subsidiaries, agencies (advertising, promotional, fulfillment and marketing), their immediate families (parent, child, sibling, spouse) and persons living in the same household as such individuals (whether related or not) are not eligible to participate in the Giveaway. By entering the Giveaway, participants agree to release, discharge and hold harmless the Sponsor, Kennewick Waste Management, their respective affiliates, subsidiaries, retailers, agencies and their respective officers, directors, employees and agents from any and all damages, whether direct or indirect, which arise out of participation in the Giveaway or any portion thereof, or the acceptance, use, misuse or possession of the prize.
- 4. HOW TO ENTER.** City of Kennewick utility billing customers enrolled to receive electronic statements prior to the start of the Promotion Period will automatically be entered. City of Kennewick utility billing customers not enrolled to receive electronic statements can enter by completing the on-line entry form on the City of Kennewick's webpage at [www.go2kennewick.com](http://www.go2kennewick.com) during the Promotion Period, and request to receive all future billing statements electronically for the utility billing account(s) provided. Limit: Only one entry allowed per person/family/household. Multiple entrants are not permitted to share the same email address, home address or contact information. If multiple responses are submitted or multiple email addresses are used, the entrant will be disqualified. By entering the Giveaway, participant agrees to these "Official Rules."
- 5. DRAWINGS/PRIZES/ODDS OF WINNING.** On or about, December 21, 2016 a random drawing will be conducted by Sponsor from all eligible entries received prior to the drawing. A total of four (4) drawings will be held. Each drawing will award a \$50 Visa Gift Card donated by Kennewick Waste Management.  
  
Odds of winning depend on the number of customers enrolled to receive electronic utility billing statements at the end of the Promotion Period.
- 6. PRIZE AWARDING.** Winners will be notified via email after December 20, 2016 . Return of any prize notification as undeliverable will result in disqualification and selection of an alternate winner.

Sponsor will award prizes only upon winner verification and final approval. ***No prize substitution, cash equivalent of prize, transfer or assignment of prize will be permitted.***

If a winner is unreachable; ineligible; fails to claim the prize or reply to the email prize award notification message within thirty (30) days of notification; or if the email prize notification message is returned as undeliverable; or if the potential winner otherwise fails to fully comply with these "Official Rules," the winner will forfeit that prize and an alternate potential winner will be determined. Acceptance of a prize constitutes the winner's permission to the Sponsor to use the

winner's name solely for advertising and promotional purposes as Sponsor so determines without notice or further compensation, except where prohibited by law.

All information collected will be treated in a manner consistent with the Sponsor's Privacy Policy. If a dispute arises, entries will be deemed made by the authorized account holder of the email address submitted at time of entry. The authorized account holder is defined as the natural person who is assigned an email address by an Internet access provider, online service provider or other organization that is responsible for assigning email addresses or the domain associated with the submitted email address. If in dispute, a potential winner must provide the Sponsor with satisfactory proof that he/she is the authorized account holder of the email address associated with the winning entry.

All decisions of Sponsor are binding and final.

**7. DISQUALIFICATION.** The Sponsor is not responsible for lost, interrupted or unavailable network server or other connections, miscommunications, failed email delivery, failed telephone or computer or telephone transmissions or technical failure, jumbled, scrambled or misdirected transmissions, or for incorrect or inaccurate entry information howsoever caused or other error of any kind whether human, mechanical or electronic. Entrants found tampering with or abusing any aspect of this Giveaway, as solely determined by Sponsor, will be disqualified. If disqualified for any of the above abuses, the Sponsor may terminate entrant's eligibility to participate in the Giveaway. If this Giveaway is compromised by virus, bugs, non-authorized human intervention or other causes beyond Sponsor's control which, in the sole opinion of Sponsor, corrupt or impair the administration, security, fairness or proper play of the Giveaway, the Sponsor may, at its sole discretion, suspend or terminate the Giveaway and will then award a prize from all eligible entries received prior to (and after, if appropriate) the action taken by Sponsor.

The Sponsor is not responsible for any entry which is generated by computer hardware or software, malfunction, error or failure, or is tampered with or subject to any non-authorized human intervention.
